(Points to note when participating)

 You can participate if you are a high school student with an immigrant background. By immigrant backgrounds, we are referring to those who do not have Japanese nationality, those who have foreign nationality, those whose native language is not Japanese, those whose parents, one or both of them, are foreign nationals, or those who are recognized by glolab as immigrant youths.

2) The copyright (the right to use or the right to decide how to use work results) and other intellectual property rights, portrait rights, publicity rights and all other rights of materials and videos provided in online events belong to glolab or their respective right holders.

3) Glolab is not responsible to prepare or bear the cost of devices and communication environment required for the online events. Depending on your usage environment, all or part of the online events may not be available.

4) Please do not engage in any of the following acts. Otherwise, you may lose the privilege to use glolab's services.

- If you have any questions or consultations regarding the diagnosis results, please use LINE consultation or face-to-face consultation.
- Diagnosis results are based on the laws and systems at the time of diagnosis and may change in accordance with changes in laws or systems.

- Please be sure not to copy, use copies of, or rewrite your diagnosis results, or post results on the internet without obtaining approval from glolab. About LINE consultation

- LINE consultation is available to immigrant youths, mainly between the ages of 15 and 24, for any consultations on status of residence, school life, family, part-time job and career path. We will listen to your concerns and provide support.
- There may be a delay before response to a LINE consultation is provided due to the circumstances of the counselor. We may also recommend a face-to-face consultation.
- When it is determined that the content of a consultation is beyond the scope of glolab, we may introduce you to other organizations or institutions.
- glolab cannot address consultations deemed to have ethical issues (goono sense of being good or bad as a person, , , inappropriate under normal social conventions (in a normal life based on manners and common sense) or not in line with the purpose of consultations (questions that have nothing to immigrant backgrounds), content that is not regarded as a consultation (ex. a monologue, rather than a question). We cannot guarantee that you will receive support as you desire. However, we do accept consultations from those in trouble without a state of residence.
- Tips and information provided by glolab's staff may not necessarily improve your situation with absolute certainty. Please make your own decision whether or not to follow the tips at your responsibility.
- If the counselor determines that the consultation has been completed, the consultation may be terminated at the request of the counselor.
- Please do not spread the content of consultations through social networking media or post it on the internet.
- glolab shall record the content of consultations, advice and information provided by our counselors.

- glolab will not give any personal information, consultation content, or advice or information provided by our counselors to anyone other than glolab's counselors. However, this does not apply when;
 - we are introducing you to other organizations or agencies upon your consent to continue addressing your consultation.
 - we determine that your life is at risk or you are at a risk of getting involved in a crime, and there is a need to provide the police or child consultation office with your personal information and the content of your consultation.
 - when using such information for studies and activities to improve our consultation handling and techniques, when demanding the Japanese government to improve its policies, when disseminating information or raising issues through the media, when introducing a part of consultation content and tips provided by glolab in the newsletter. However in such circumstances, we will not include any personally identifiable information that could potentially be used to identify you.
- We may stop or decline your consultation when;

○You violate the terms stipulated in this document.

OWhen we determine that we cannot maintain a relationship of trust with you (for example, when you speak ill of glolab or other people, disseminate secrets or privacy-related information of glolab or others, or attack glolab or others verbally by name calling or spreading false information about others or glolab.)

 \bigcirc When it has become difficult to continue consultation via LINE, because your LINE ID disappeared or changed, or you have violated LINE's terms of service, etc.
